Reference is made to the announcements (the “Announcements”) of China Asean Resources Limited (the “Company”, together with its subsidiaries, the “Group”) dated 5 July 2013 and 14 August 2013 in relation to, amongst others, postponement of the meeting of the board (the “Board”) of directors (the “Director”) of the Company and delay in publication of annual, first quarterly and interim results, annual, first quarterly and interim reports of the Group for the year ended 31 December 2012, three months ended 31 March 2013 and six months ended 30 June 2013, respectively.

**FURTHER DELAY IN PUBLICATION OF ANNUAL RESULTS ANNOUNCEMENT AND
DESPATCH OF ANNUAL REPORT FOR THE YEAR ENDED 31 DECEMBER 2012**

Pursuant to Chapter 18 of the GEM Listing Rules, the Company is required to publish its annual results and annual report no later than three months after the date upon which its financial year ended, that is, by 31 March 2013. As additional time is required for the Group to finalise the Company’s announcement on its annual results (the “Annual Results”) and annual report (the “Annual Report”) for the year ended 31 December 2012, including, amongst other things, further work to be conducted relating to the assessment on the fair values of the Group’s intangible assets (including goodwill) so as to conclude the potential impairment to be made (if any), the publication of the Annual Results and the Annual Report will be delayed to on or before 31 December 2013.

FURTHER DELAY IN PUBLICATION OF FIRST QUARTERLY RESULTS ANNOUNCEMENT AND DESPATCH OF FIRST QUARTERLY REPORT FOR THE THREE MONTHS ENDED 31 MARCH 2013

Pursuant to Chapter 18 of the GEM Listing Rules, the Company is required to publish its first quarterly results and its first quarterly report for the three months ended 31 March 2013 on a date not later than 45 days after the end of such financial period, that is, on or before 15 May 2013. Due to the delay in publication of the Annual Results and the Annual Report as described above, the Company's first quarterly results and first quarterly report for the three months ended 31 March 2013 was not able to be made on 15 May 2013 and is expected to be delayed to on or before 31 December 2013.

FURTHER DELAY IN PUBLICATION OF THE INTERIM RESULTS ANNOUNCEMENT AND DESPATCH OF THE INTERIM REPORT FOR THE SIX MONTHS ENDED 30 JUNE 2013

Pursuant to Chapter 18 of the GEM Listing Rules, the Company is required to publish its interim results and its interim report for the six months ended 30 June 2013 on a date not later than 45 days after the end of such financial period, that is, on or before 14 August 2013. Due to the delay in publication of the Annual Results, the Annual Report, the Company's first quarterly results and first quarterly report for the three months ended 31 March 2013 as described above, the Company's interim results and interim report for the six months ended 30 June 2013 will not be made available on 14 August 2013 and is expected to be delayed to on or before 31 December 2013.

SUSPENSION OF TRADING

At the request of the Company, trading in the securities of the Company on the Stock Exchange has been suspended from 9:00 a.m. on 2 April 2013, and will remain suspended until the fulfillment of the resumption conditions mentioned in the announcement of the Company dated 9 September 2013.
